- (iii) The "**Valuation Date**" / "**Optional Redemption Valuation Date**" shall be **25 July 2022**;
- (iv) The "**Redemption Date**" / "**Optional Redemption Date**" shall be **29 July 2022** (i.e. 4 Business Days following the Valuation Date).

Capitalised terms not defined in this notice shall have the same meaning given to them in the conditions of the Securities or in the Base Prospectus, as applicable.
